The short-listed candidates are advised to appear for Document Verification on the date, time and venue, as mentioned above.

Only those candidates whose documents are found in order shall be allowed to appear for Computer Proficiency Test (CPT) which shall be qualifying in nature only. However, only those candidates, who are found FIT by the Committee in CPT, shall only be considered for inclusion in Final Merit list-cum-Selection list based on their marks in the Written Test. The details of selection process for CPT is already mentioned in our website notification dated 07.08.2018.

**DOCUMENTS REQUIRED FOR VERIFICATION**

The following original documents along with self-attested copies are required to be furnished at the time of CPT:

- i) 10<sup>th</sup> pass/ Matriculation certificate issued by the concerned education board as proof of Date of Birth. No other document will be accepted for verification of Date of Birth.
- ii) Caste (SC/ST/OBC) / Tribe / Disability certificate of reserved category candidates in the prescribed format issued by the Competent Authority.
- iii) For claiming the benefit of OBC category, the candidate should submit a latest OBC certificate in the proforma prescribed by Govt. of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel &

Training, Government of India OM No. 36012/22/93- Estt.(SCT) dated 08.09.1993. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Further, name of OBC caste mentioned in the certificate should fall in the Central list of OBCs of the respective state and non creamy layer status should be valid as on 07.08.2018.

- iv) Semester-wise / year-wise mark sheets and Final Certificate of 10<sup>th</sup>, 12<sup>th</sup> & Full-time Graduation degree.
- v) Wherever CGPA/OGPA or Letter Grade is awarded in the Graduation degree examination, its equivalent aggregate percentage of marks must be indicated in the Online Application Form as per the norms adopted by University/ Institute. The supporting document should also be produced at the time of CPT in case the candidate gets shortlisted for CPT.
- vi) No Objection Certificate, in case of candidates employed in Government / Semi Government / Public Sector Organization.
- vii) One Passport size colour Photograph (preferably matching with the one used in application form)
- viii) For the purpose of this recruitment exercise, only those Persons with benchmark Disabilities as mentioned against the respective post codes in the Website Notification dated 07.08.2018, who are having **minimum 40% disability** shall be considered as a PwBD candidate. Relaxations/concessions as provided by the Rights of Persons with Disabilities Act 2016 shall be duly admissible.

**Please note the following:**

PwBD candidates only with the following specified disabilities shall be considered in terms of clause (zc) of section 2 of the Rights of Persons with Disabilities Act, 2016, for the respective notified posts:

**“Low Vision”** means a condition where a person has any of the following conditions, namely:

- (i) visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
- (i) limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

**“Hard of Hearing”** means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears.

PwBD candidates having disabilities other than the above, need not to come for further selection process and their candidature shall not be considered for the notified post.


- ix) Any other Certificate, if applicable

**IMPORTANT**

1. Without original documents, candidates shall not be allowed to appear in CPT.
2. After checking, original documents shall be returned to the candidates on the same day and only the self-attested copies shall be retained by IOCL. Candidate himself shall be responsible for safe custody of original documents.
3. During document verification before the CPT or at any stage of selection process, in case it is detected that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s) or is unable to produce original documents or possesses higher qualification, his/her candidature will stand cancelled.
4. The information furnished by the candidate in the online portal with regard to qualification, age, category etc. shall be cross-checked from the original documents of the candidates.
5. Please note that during subsequent verification of documents; in case the revelation is contrary to your claim, your candidature will be summarily rejected at any stage of the selection process or later without any further notice to you.

His/her candidature for this test is provisional and is subject to his/her fulfilling the educational and other eligibility criteria prescribed for the post.
